This course focuses also on Introduction to Techniques of Differentiation, The Product and Quotient Rules- Derivatives of Exponential Functions- Derivatives of Logarithmic Functions Derivatives of Trigonometric Functions- Derivatives of Inverse Trigonometric Functions. Derivatives of Hyperbolic Functions, Derivatives of Inverse Hyperbolic Function- the Chain Rule, Parametric differentiation, Implicit Differentiation- Maximum and Minimum Values-Increasing and Decreasing Functions, Concavity and the Second Derivative Test, L'Hospital's Rule- Indeterminate Forms, Rolle's Theorem- Mean-Value Theorem, Maclurin's and Taylor's Theorem.
